Stottlemeyer is questioning TOMMY DORN, who used to play "Andy Cooper". Dorn is now 40-ish. He's worn down. A junkie. Almost unrecognizable.

Stottlemeyer waves XEROX COPIES of the THREATENING LETTERS.

START



CAPT. STOTTLEMEYER  
You wanna take another look?

TOMMY DORN  
I don't have to. I didn't write 'em.

CAPT. STOTTLEMEYER  
What about this morning, Thomas.  
About 7:45?

TOMMY DORN  
I was in bed. Alone.

CAPT. STOTTLEMEYER  
That's unfortunate.

TOMMY DORN  
I agree.

Stottlemeyer shows Dorn the blurry surveillance photo, of the SUSPICIOUS MAN IN THE CONDORS SWEATSHIRT.

CAPT. STOTTLEMEYER  
Is this you?

TOMMY DORN  
That could be anybody.

CAPT. STOTTLEMEYER  
I didn't ask if it was anybody.

TOMMY DORN

CAPT. STOTTLEMEYER

Do you have a sweatshirt like this?

During this, Monk appears behind them, in a glass window. Monk grins at Tommy, like an obsessed fan.

TOMMY DORN

I told you, it's not me. Am I some kind of suspect?

MONK

(gleefully, through glass)

SHUCKY DARNs!

Stottlemeyer and Dorn turn. Monk raps excitedly on the glass! Tap tap tap! He waves!

MONK (CONT'D)

TOMMY! SHUCKY DARNs!

Stottlemeyer sighs. He opens the door, and drags Monk into the office. Monk is thrilled to meet "Andy Cooper".

MONK (CONT'D)

That's what he said on the show. Almost every week.  
(to Dorn)  
Remember?

TOMMY DORN

(sarcastic)  
Do I remember? Yeah. It sorta rings a bell.  
(to Stottlemeyer)  
Who is this guy?

MONK

I'm Adrian Monk. Have you been receiving letters, too?  
(to Capt. Stottlemeyer)

~~Oh my God. He must be after the whole cast!  
(to Dorn)~~

~~It's gonna be okay. We have a photo of the guy. We have samples of his handwriting.~~
